The meeting was called to order by M. Bard at 7:03

Approve Agenda

R. Clapp made a motion to approve the agenda which was seconded by D. Kehlmann.

A. Johnson asked for time to update the board on the Housing Taskforce. K. Petrovic asked for consideration of granting alcohol consumption at Rusty Parker Park as part of Winterfest. Both items were added to the agenda under Select Board; Items b.) and c.) **A vote was held on the amended agenda and passed unanimously.**

Consent Agenda Items

a.) Approve moving liquor licenses for Hen of the Wood; Approve 2nd class liquor license for Brockton Corporation (Shaw's); Approve 2nd class liquor licenses for Wesco, Inc (Shell Station Route 100 & Champlain Farms)

D. Kehlmann made a motion to approve the consent agenda. The motion was seconded by C. Viens and passed unanimously.

Public

C. Shank alternative representative for CVFiber introduced himself to the board and asked for ARPA funding in the amount of \$50,000 to be placed on the warning for voter consideration in March. There are matching funds available.

Select Board Items

Decision on Town Meeting Day Style

Staff was able to reach Will Senning at the Secretary of State office and confirm that Waterbury cannot "use the Australian ballot system at the same election at which its voters decide that the system shall be used." **R. Clapp moved to keep open Town meeting as has been traditionally held on March 7th 2023 at 9am and draft an advisory question to the community regarding changing Town Meeting Day style. The motion was seconded by C. Viens. Staff was asked to draft an advisory question for Town Meeting. A vote was held and passed unanimously.**

Housing Task Force Update

A. Johnson let the Board know that the taskforce will be holding its first public meeting this

Wednesday January 25, 2023 at 6pm in the Steele Community Room. The agenda is available with zoom on the Town website.

Consideration of alcohol consumption at Rusty Parker Park

K. Petrovic read excerpts of an email she received late in the day from one of the organizers of Winterfest. *“Big Tree Brew Tasting Event - 1:30 pm - 3:30 pm. Party in the Park ends at 4:00”*
“Winterfest can rope off a section in the middle of the park between the fat tire demo - near Main St. and Snow Volleyball between the band stand & gazebo with Bocce along the side parallel to Park Row. We have rope and stakes” The catering permit K. Petrovic can approve herself once received but she required Select Board approval for them to serve at the park. **A. Johnson made a motion to approve as presented. C. Viens seconded the motion. A vote was held and passed 4-0 with R. Clapp recusing himself.**

Managers Items

Cemetery Budget Review

T. Leitz reviewed the Cemetery Budget with the board. The revenue did not meet budget in 2022. The Cemetery Commissioners are working on completing a job for a cemetery sexton. Grass Choppers has let the Town know they will no longer be performing maintenance of the cemeteries. The PWD is searching for a new company but labor shortages are proving difficult. Public Works will have to do it until a new contractor can be found.

Health and Social Services Budget

T. Leitz reviewed the Health and Social Services Budget with the board. The position of Health Officer will remain with the Manager and Chair of the Select Board for the time being. Parking enforcement is currently be handled by Public Works in the way of having cars towed when necessary for plowing. There has been discussion about a compensation package for employees that are responsible for patrolling streets during the winter parking ban. T. Leitz will continue to explore options and update the board. Hiring an Animal Control Officer was also discussed with ideas regarding a compensation package for that position. The board asked when the last time this was advertised and staff could not recall specifically. Once compensation is finalized the position will be advertised again.

2023 Major Capital Expenses and Funding Plan

T. Leitz provided a brief summary of major changes to Capital Expenses. See attached

Review and Approval/Denial of ARPA requests

Correction to Highway Department \$95,000; updated total for Unspent/Pledge Balance is \$1,219,964

Spring Hill School - request is denied – T. Leitz to reach out to them with update

Senior Center – consensus to table the discussion until the Center has more concrete information about kitchen costs

Town Bridges – consensus to place \$435,000 in the budget.

Gravel Road Initiative - consensus to place \$30,000 in the budget.

Reappraisal – following a lengthy discussion Board consensus is to use \$200,000 in ARPA funds

to conduct a town wide reappraisal and move the current reserve funds to Capital Improvements. This will be in the budget.

Downstreet Housing - consensus to place \$100,000 on the warning for Town Meeting EFUD – following a lengthy discussion about EFUD’s generosity to the community with waived rates and fees from 2020-2022 the Board consensus is to place \$150,000 in the budget to be transferred to EFUD to offset the lost revenue.

CVFiber – the request for funding is denied – C. Shank was still present for the decision so no follow up is necessary.

At the close of the discussion there remained roughly \$305,000 unpledged with the Senior Center kitchen upgrade remaining an open dialogue.

Special Articles

T. Leitz updated the board the Rotary will not be requesting special funding for Concert in the Park series. They will however request funding for park maintenance. This will not require attention; it is embedded in the parks budget.

The question came up why the Senior Center has funding in the budget as well as a Special Article. The history was to have it budgeted until they once came with a “one time” request. This one-time request was considered for Special Article and has been a Special Article ever sense. There were three funding options, by consensus the board decided to have \$12,500 left in the General Budget and the increase placed as a Special Article. This change brings the Special Article ask to \$26,500 in 2023

Tax Rate

T. Leitz has been working with D. Sweet and they do not expect a large increase to Grand List Values in 2023. At the time of the meeting the anticipated Municipal tax rate is .5411 cents, an increase of roughly one cent. Some discussion followed regarding bridge work where it was noted that because the Stowe Street bridge is being replaced with State funding options there will most likely not be State funding options for the Union Street / Main Street bridge and this work also needs to be done.

Seeking Selectboard guidance on public utility filing related to a temporary wireless facility at 91 State Drive

Consensus of the board it positive to having increased cell service in Waterbury. T. Leitz will write a letter of support.

Other Business

Discuss February meeting agendas (Municipal office is closed on 2/20)

The board will meet Monday January 30th with a focus on the Town Meeting Warning
The board will then meet again on February 13th and 27th. K. Petrovic to reach out to J. Kilgore to ask if he can join the February 27th meeting.

R. Clapp made a motion to adjourn seconded by D. Kehlmann. A vote was held and passed unanimously. There being no further business the meeting was adjourned at 9:40pm.

Re: Edward Farrar Utility District Request for Reimbursement

For a period encompassing 7 quarters EFUD waived or reduced water and sewer base charges, along with interest and penalties for late payments. We have calculated this lost revenue to EFUD as roughly \$300,000. Please note this \$300,000 does not include some penalty and interest charges that were waived as our water/sewer billing system does not allow for EFUD to estimate these losses, the figure is therefore understated. The \$300,000 calculation excludes charges that were reduced/waived for EFUD's customers that do not live in the Town of Waterbury, and that EFUD did *not* reduced charges for the State of Vermont.

EFUD formally requests reimbursement from the Town via an allotment of ARPA funds.

We can all recall how hard - just a few years ago - the retail sector was impacted by COVID. Restaurants, in particular, faced dramatic and costly impacts, and were appreciative that EFUD elected to reduce their expenses. I note that about 45% of all waived charges applied to commercial customers, and 55% applied to residential customers, so EFUD's reduction to assist its customers had a broad impact on the Town and did not focus on one specific type of customer. The Commissioners of EFUD, in short, focused on providing broad based relief that was both effective and immediate.

This loss of \$300,000 had a meaningful impact on EFUD's finances. While EFUD will continue to pursue projects that expand the reach of the water/sewer system, particularly in Waterbury Center, the lost revenue makes advancing these projects more difficult. Preliminary engineering expenses for water and sewer line expansions, even those projects that may seem minor in scope, can easily exceed \$50,000. Preliminary engineering is typically a prerequisite to determine project feasibility and to seek state and federal grant funding.

The erosion of EFUD's bottom line also makes responding to emergency situations, and simply conducting normal operations, both more difficult and more costly. This past December, for example, EFUD has to borrow (and pay interest on) \$45,000 to meet its obligations. ARPA funds could stabilize EFUD and allow for some reserves in the event of emergency repairs.

Finally, the Town had previously allocated \$95,000 in ARPA funds to reduce taxes on property owners. This did not come at a cost to the Town, whereas EFUD provided a more meaningful reduction to its customers, but at a direct cost. The original ARPA legislation tied funding to actual lost revenue; this request for funds is consistent with the original spirit and intent of the law.

NOTICE OF FILING OF PETITION

I, Brian J. Sullivan, attorney for Bell Atlantic Mobile Systems, LLC d/b/a Verizon Wireless (“Verizon”) do hereby give notice that, on January 9, 2023, Verizon filed an Application for a Certificate of Public Good and its supporting documents (collectively, “Petition”) with the Vermont Public Utility Commission (“Commission”) pursuant to 30 V.S.A. § 248a for a temporary wireless telecommunications facility on a parcel (“Parcel”) at 91 State Drive in Waterbury, Vermont that contains a building owned by the State of Vermont Department of Buildings and General Services. The Parcel is an approximately 60-acre lot, that is part of a larger complex of State Buildings including that of the Vermont State Police. The provision of the service will directly benefit the State Police communications infrastructure. Verizon refers to the project as the “Waterbury DT Ballast Tower” because the tower portion of it will sit on the ground, weighted down by ballast rather than attached to a foundation. The property owner has given Verizon permission to proceed with this Application. The coordinates for the Project are latitude 44°19’50.18” North and longitude 72°45’05.51” West. Verizon filed the Petition using the Commission’s ePUC web portal.

Pursuant to the Commission’s *Sixth Amended Order Implementing Standards and Procedures for Issuance of a Certificate of Public Good for Telecommunications Facilities Pursuant to 30 V.S.A. § 248a*, entered in Case No. 18-2940-INV on September 21, 2018 (“Procedures Order”), on January

18, 2023, we served the Petition, via ePUC and U.S. Mail on the parties listed below.¹

I hereby inform the recipients below that they have until February 17, 2023 to file comments, motions to intervene, or requests for hearing on the Petition with the Commission. On January 9, 2023, the Vermont Public Utility Commission (“Commission”) received your petition to construct a facility in Waterbury, Vermont.

Commission staff have determined that your petition is administratively complete. Your case number is 23-0050-PET.

The period for public comments, motions to intervene, and requests for hearing will end on February 17, 2023.

With the exception of those state agencies that will receive notice of and access to your petition via ePUC, you must provide a copy of your petition pursuant to the Commission’s August 12, 2016, order establishing standards and procedures for issuance of a certificate of public good for telecommunications facilities pursuant to 30 V.S.A. § 248a to all entities and persons entitled to receive such copies and notice within 2 business days of this memorandum.

owner has given Verizon permission to proceed with this Application. The coordinates for the Project are latitude 44°19'50.18" North and longitude 72°45'05.51" West. See Permit Plans (Exhibit LH-1; "Plans") for a visual depiction of the Project's location.

4. Due to issues affecting the Vermont State Police's use of Verizon's network in Waterbury, Verizon has deployed a short-term "cell on wheels" portable site at this location. For a longer term, until a permanent solution can be found, Verizon must erect a temporary ballast tower ("Temp Tower") to ensure that its service in this area is not interrupted. Verizon expects the Temp Tower to remain in place for approximately two (2) years.

5. Verizon proposes to mount a total of three (3) antennas ("Antennas") and nine (9) Remote Radio Heads ("RRHs") centered at 76' above ground level ("AGL") on the 85' AGL Temp Tower on three (3) "standoff arms," with one (1) Antenna and three (3) RRHs per side or "sector". Each of the Antennas will measure approximately 72.76" long and 19.61" wide. The topmost point of the antennas will extend to a height of approximately 79' AGL.

6. Six (6) of RRHs, each measuring approximately 15.9" long and 15.5" wide and three (3) of the RRHs, each measuring 14.96" long and 14.96" wide, will be mounted behind the Antennas. One (1) OVP distribution box ("OVP"), measuring approximately 29.5" long by 16.5" wide will be mounted on the Temp Tower below the Antennas and the RRHs. The Temp Tower, OVP, RRHs and Antennas will be painted brown. Full and accurate specifications of the proposed Antennas, RRHs and Distribution Box are detailed in Exhibit MM-1.¹

7. The Temp Tower has been evaluated and designed to support the proposed equipment. See structural analysis in Exhibit LH-2.

¹ From time to time, equipment manufacturers may slightly alter their products or Verizon may purchase from different suppliers. Therefore, there is a possibility that the actual antennas may differ slightly from what is described in the attached specifications.
