Dear Karen:

Thank you for requesting a budget for desired improvements to the website in 2025. Since 2010, we've served Waterbury with a reliable and affordable service that has adapted over time to meet the Town's evolving website needs.

2025 Waterbury Website Needs

Website improvements:

- **News & Initiatives section:** Create a new area of the website similar to the one that Ecopixel created for the City of Essex Junction. Ecopixel would work with Karen Petrovic on the content structure and then build out the section as needed. We estimate 5 hours for this work.
- ADA compliance review and improvements: It has been 3 years since the last major ADA compliance review and related website improvements. Ecopixel would spend 10 hours reviewing and improving the website's compliance. In April 2024, the US Department of Justice issued a final rule that requires local governments to comply with the ADA by following an international standard called WCAG 2.1 level AA. While the deadline for compliance isn't until 2027, Waterbury should act sooner to ensure its website serves the whole community.
- Page layout improvements for mobile visitors: About 50% of website visitors are using a mobile device. On small mobile device screens, older page layouts cause important information like departmental contacts to move to the bottom of the page. Ecopixel will change the layout of these pages so this important information is shown near the top of the page, regardless of screen size. We've budgeted 5 hours for this work.

Website service plan:

Bring Waterbury up-to-date with Ecopixel's current service. Major benefits include:

- ADA compliance: Going forward, we need to transform this from a periodic task into an
 ongoing one in order to ensure the website is meeting compliance requirements. We have
 budgeted 5 hours/year for this work.
- Meeting recordings: The updates will make it easier for Town staff to post meeting recordings
 as required by Vermont's Open Meeting Law.

- **Supporting additional staff:** More staff need to access the website to maintain content for their committees. Going forward, we'll set up and support any number of website editors to suit Waterbury's needs.
- Meeting calendar and document management: All of the documents related to a single
 meeting are grouped together agenda, packet, minutes as well as meeting date and minutes
 approval status. You don't have to go to different places to find it. Meetings and their documents
 are automatically archived by date and board/committee.
- Email notifications: Ecopixel would integrate the website directly with Mailchimp (already
 used by the Town) to send meeting and news notifications to subscribers. It saves staff time since
 you wouldn't need to log into Mailchimp to send typical meeting notices, and any number of
 staff could have access to send such notifications. Relevant minutes and agendas are linked
 directly to the emails.

- News & Initiatives section: \$480
- ADA compliance review and improvements: \$960
- Change page layouts to help mobile device users: \$480
- Website service plan: \$2,489/year
